

1. Vice President, Kings Inn Family Shelter

CAMBA's The Kings Inn Family Shelter is funded by the New York City Department of Homeless Services and offers families a supportive, structured therapeutic, safe, and drug-free facility. It provides comprehensive case management services to 100 families who are in a transitional residence program for homeless families. The two-story facility has rooms of various sizes, and common areas and provides on-site security and social services.

The Vice President is expected, under general direction, to (1) manage one or more programs that require contact with internal and external clients and/or the community; (2) understand all aspects of contract requirements and communicate this understanding to staff; and (3) participate in program design. Oversees the day-to-day operations of the shelter and the operations and social service teams. Meet all contractual obligations well staying in compliance with the policies and procedures.

Minimum Education/Experience Required:

- Bachelor's degree (B. A.) and three years of applicable experience and/or equivalent experience. Master's degree preferred. (A license is required of these Master's Degrees: Social Work (LMSW or LCSW), Mental Health Counseling, Counseling/Guidance, Art Therapy).
- Ability to be on call 24 hours a day, 7 days a week.
- Must sign NYC DOH/MH attestation stating that candidate has not been the subject of a founded child abuse report.
- Oversee the day-to-day operations of the shelter and the operations and social service teams.
- Meet all contractual obligations well staying in compliance with the policies and procedures.

The **Client Care Coordinator** is expected, under general supervision, to: (1) provide individual and/or group counseling services to assist clients and their families to achieve healthy relationships, emotional stability, personal development and/or adjustment; and, (2) counsel clients regarding issues such as: abusive behavior, family dynamics, healthy personal choices, substance abuse, mental and physical health/trauma related issues.

Minimum Education/Experience Required:

- Licensed Master of Social Work (LMSW) required
- Licensed Master Social Worker (LMSW) required within one year of date of hire. This license must be maintained throughout the course of employment in this role and any other CAMBA positions for which it is required. If you fail to obtain your LMSW within one year of the date of hire, your orientation period may be extended for six months at CAMBA’s discretion. If you fail to obtain the required LMSW on CAMBA’s required timeline, you will be terminated.
- Must obtain State Central Registry (SCR) clearance, The Register of Substantiated Category One Cases of Abuse or Neglect aka Staff Exclusion List (SEL) clearance and Criminal history information checks via fingerprinting with New York State Division of Criminal Justice Services prior to start of employment.

(A license is required of these Master's Degrees: Social Work (LMSW or LCSW), Mental Health Counseling, Counseling/Guidance, Art Therapy).

- Licensed Master Social Worker (LMSW) required within one year of date of hire. This license must be maintained throughout the course of employment in this role and any other CAMBA positions for which it is required. If you fail to obtain your LMSW within one year of the date of hire, your orientation period may be extended for six months at CAMBA's discretion. If you fail to obtain the required LMSW on CAMBA's required timeline, you will be terminated.

The **LMSW Consultant** will complete psychiatric evaluations that assess and diagnose clients for mental health, behavioral, emotional, or addiction disorders. Works closely with the different shelter teams to

schedule and complete the psychiatric evaluation. Weekly hours will vary depending on the need of the program.

Minimum Education/Experience Required:

- Licensed Master's degree in social work or mental health counseling required
- Preferable 2 years of experience with administrating and documenting psychiatric evaluations
- Must be willing to travel to different site locations in different boroughs
- Requires the ability to exercise discretion and use good judgment to perform duties promptly and consistently with little direction. Ability to maintain confidentiality at all times
- Ability to read and understand oral and written instructions, and effectively communicate information
- Document and report on findings and outcomes with all client interactions
- Strong computer skills
- Display strong theoretical knowledge of psychopathology and appropriate treatment and provide appropriate referrals and follow-up when needed
- Excellent interpersonal skills necessary to communicate with the different social service teams at the shelters and with clients
- Bi-Lingual in Spanish preferred
