In the aftermath of the September 11th attacks against the United States in 2001, the Security Council unanimously adopted resolution 1373 (2001), which for the first time established a dedicated Counter-Terrorism Committee (CTC) of the Council. The CTC is assisted by an Executive Directorate (CTED), which carries out its policy decisions and conducts expert assessments of the 193 United Nations Member States.<sup>1</sup>

There are two crucial topics facing our world today, terrorism, that need to be tackled to save the fate of the world. The first topic we will be discussing is the rise of technology use in the planning, attacking, and recruiting for different terrorist organizations. With technology rapidly advancing
